**INFORMATION NOTICE ON**  
**CLOSED CIRCUIT CAMERA RECORDING SYSTEM**

This notice is prepared to inform data subjects on the procedures and principles regarding the personal data recorded and processed via closed circuit camera recording system set in the Şişli Turizm Yatirimlari İnşaat Sanayi Ve Ticaret A.Ş. (Company) in accordance with the Turkish Law No. 6698 on the Protection of Personal Data (Act No. 6698)

**1. The Purpose Of Processing The Personal Data:**

The personal data recorded as video footage, are being processed in accordance with the data processing conditions set forth in 5<sup>th</sup> And 6<sup>t</sup> Articles of the Act No. 6698 for the purposes below:

- To execute the procedures on emergency situations,
- To ensure hotel security
- To conduct internal audit/investigation processes,
- To ensure the security of movable goods and resources,
- To resolve legal conflicts,
- To fulfill the demands of authorized institutions and organizations

**2. The Parties to Whom Recorded Personal Data May Be Transferred , and Purpose of Transfer:**

The personal data recorded are being transferred for the purposes below in accordance with the data processing conditions set forth in 8<sup>th</sup> And 9<sup>th</sup> Articles of the Act No. 6698:

- To execute the procedures on emergency situations,
- To ensure hotel security
- To ensure the security of movable goods and resources,
- To resolve legal conflicts,
- To fulfill the demands of authorized institutions and organizations

Personal data are being transferred to the law firm providing legal services to the Company, authorized institutions and organizations and the Spa Center located at the Health Center owned bythe Company. It also needs to be stated that the Spa Center located at the Health Center owned bythe Company is authorized to conduct simultaneous camera surveillance of the pool, fitness center and reception by which personal data are being transferred to Spa Center.

**3. The Means and Legal Reasons of Data Processing:**

The Personal Data are being collected automatically via Camera Recording Systems installed in the Company premises and processed under the legal reason defined as “being necessary for the legitimate interests of the data controller, provided that the fundamental rights and freedoms of the data subject are not harmed” in the 5<sup>th</sup>Article of Act No. 6698.

**4. Rights of the Data Subject and Exercise of These Rights:**
